Northstone's Connecting Communities to Nature

Northstone's Connecting Communities to Nature Commitment is an overarching statement of intent outlining the aims of current and future Northstone developments, aiming to improve the natural capital assets of the area, underpinned by people and development.




- Strive to voluntarily increase biodiversity on our sites by at least 10 percent for the benefit of local residents and wildlife.
- Support local wildlife by incorporating bat boxes, bird boxes, hedgehog-friendly fences and refugia into our plans, ensuring site layouts facilitate the movement of local wildlife.
- Design Code for each site, incorporating hedgerows, trees, and evergreen perennial shrubs.

- Enhance existing urban woodland and ponds where possible.
- Follow best practice in habitat management and aim to maintain local distinctiveness by using native plants where possible.
- Aim to build a habitat network throughout the built environment, providing residents with frequent interactions with nature and its associated health benefits.

- Integrate sustainable urban drainage schemes, where appropriate, that benefit local wildlife as well as improving water management.
- Increase access to nature where possible by incorporating health walks and play areas throughout our schemes.
- Provide wildlife education boards for residents at interesting points around our sites.

Highlights from 2021/22

Jacob's Place

We understand that in order to build truly sustainable communities, we must take an inclusive approach to safeguard all types of living. This is why, as part of our commitment to SDG 11: Sustainable Cities & Communities, over the coming years we will be extending our housetype offer to include bungalows, dependent relative living, and multi-generational homes.

Jacob's Place is a bespoke adapted housetype designed to provide accommodation for families with dependent relatives who may not have been in a suitable accommodation previously. The housetype, which will be built at our Silkash development in Bolton, provides an adaptable living environment and includes a ground floor bedroom and bathroom. Northstone intends for Jacob's Place to be rolled out across all of our sites in the North West.



Working Within Our Communities

As part of our commitment to SDG 8, over the past year Northstone has been working closely with local schools in Wigan and GMCA to provide long term support. Many of our Northstone team have taken part in enterprise activities at our development sites and within the schools themselves. The enterprise activities are an interactive way for young people to develop their employability, understand the workings of a business and their capabilities within them, and broaden their economic understanding.

In summer 2021, Northstone invited Bolton 6th Form students to come and spend the day at Silkash, our first development in Westhoughton, Bolton. The day consisted of various fun activities to give the students a flavour of a few possible career paths offered within a housing development company and beyond! Students got the opportunity to discuss their A-level choices with Northstone and ask for advice on potential future pathways for them including University degree choices and apprenticeship schemes.

Apprenticeships

Northstone is committed to the training and development of young professionals to increase skills within the sector and provide a variety of job opportunities within the areas we develop. Therefore, one of our 5-year targets under SDG 8 is to introduce a formal process for enabling apprenticeship opportunities with a commitment of one new apprenticeship placement per year via Northstone/our supply chain for each of our housing schemes.

We are currently exceeding this target, supporting four apprentices across our Silkash and Keld developments and hope this number will increase over the coming years.



Tayla Castley is an apprentice working on our Silkash development. She has been training as a floorer since she was 15 working with D&G flooring every Saturday until leaving school at 16 and becoming a full time employee. Since joining, Tayla has learnt a range of skills, received health & safety training, and made good relationships with the Northstone site team. Tayla is hoping to complete her training over the next year and plans to continue her career in flooring.

Waste Capture Scheme

As part of our commitment to SDG 12, last year we initiated a Waste Capture Scheme with the aim to quantify and qualify the materials wasted during the construction phase of a new build Northstone home. The Waste Capture Scheme is taking place at our Silkash site in Bolton and is due to be completed in April 2022. Once complete, Northstone intends to use the waste transfer notes collected from the plot as a baseline for reducing significant waste materials in future developments with the overall goal of reducing the carbon footprint of every new home we build. To solidify this commitment to reducing our waste production, one of our annual SDG 12 sustainability targets is to divert at least 95% of construction waste from landfill and target a minimum of 5% (aiming for 10%) reduction in normalised waste generation over the next year at Silkash.



Waste Capture Scheme

The Waste Capture Scheme is a Northstone initiative aiming to quantify and qualify the materials wasted during the construction phase of a new build Northstone home. Northstone intends to use this initiative as a baseline for reducing significant waste materials in future developments with the overall goal of reducing our carbon footprint.

Why?

- To understand the significant waste contributors that are generated from one house build to better appreciate our impact on the environment.
- To understand how Northstone can improve our handling of waste to ensure waste is reduced, reused, or recycled wherever possible.
- To evaluate how Northstone can further reduce the impacts of construction waste.

Workers



- Take care when handling waste.
- Ensure all waste is disposed of into the correct skip.
- Communicate with others about the initiative.
- Ask any questions about the scheme if you want to understand more.
- Take care when working around the camera installed on the plot.



- Avoid putting any personal waste in the skips of plot 118.
- Put waste from other plots into the designated skips for plot 118.
- · Remove any waste from the skips.

Progress against targets

Our four commitments are underpinned by 9 five-year targets, each with their own annual goals to achieve. Northstone has achieved, or are on track to achieve, all of our 9 one-year targets for our first sustainability plan, which concludes in June 2022.

SDG 12: Responsible Production & Consumption



Our Target

- Trial new emerging technologies at our Silkash scheme to gain an understanding of how to achieve a net-zero carbon home within the next financial year.
- Initiate an assessment of construction waste from our house type at Silkash and target 5% per annum reduction through waste management measures.
- Initiate an embodied carbon assessment of a Northstone housetype to understand high-carbon material elements & set a road map for reducing the embodied carbon levels over the next 5 years.

Progress

- We are currently trialling an Air Source Heat Pump at one of our homes at Silkash. Bills will be collected from the house and compared with bills from a house type of the same size with a gas boiler to understand the difference between standard practice and low-carbon methods of heating.
- We are currently undertaking a Waste Capture Scheme at our Silkash development. The scheme will tell us the quantity of waste production from a single plot and the most significant waste streams arising. The plot is due for completion in April and is intended to be used as a baseline for reducing the waste of our houses in the future.
- An embodied carbon assessment has been completed for Northstone's 1277 housetype. The assessment has helped Northstone understand material target areas for reduction in terms of the amount of carbon each possess. The assessment will be used to inform our roadmap to Net-Zero.


- Our 'Gen 2' house type range has been finalised and incorporates Jacob's Place, bungalows and houses designed specifically for multi generational living.
